TEAM COSTS:

The assessment fees for this year's teams will be announced on Monday, June 8th, and are expected to be as follows:

World's Team: \$1000 - \$1500 (covers flights, accommodations, meals, equipment, coaching, and uniform package)

CanAmMex Team: \$800 - \$900 (covers accommodations, equipment, coaching, regatta fees/ club usage, and uniform package)

Those athletes selected to the CanAmMex team will be required to commit to the following dates of travel, training and competition:

July 13 th	Athletes arrive in Tennessee
July 13 th – 14 th	Training Camp
July 15 th – 19 th	CanAmMex Regatta
July 19 th	Athletes depart for home
